Driven by concerns of health, education & equality for vulnerable women as an integral and critical dimension of human rights, Ladli Foundation became a reality in 2012 as a grassroots social catalyst. It was founded by Devendra Kumar, whose incredible journey began as a child laborer in a poverty-stricken environment. Where he faced numerous hardships and atrocities during his orphaned and challenging childhood. Born in a crime-prone slum, he endured abandonment by his parents, who left him with his three-day-old infant sister when he was just two years old. Despite these adversities, Devendra's indomitable spirit and resilience led him to find solace and purpose in serving others.

Driven by his determination to protect his sister from child marriage and dowry, Devendra founded the "Ladli Foundation" with the noble mission of uplifting the oppressed and disadvantaged. His personal experiences as a child laborer and his encounters with delinquents and drug addicts further fueled his commitment to making a positive impact in the lives of those facing similar challenges.

With a remarkable impact on over 2.5 million direct beneficiaries, Ladli Foundation has been recognized for its outstanding contributions. The Founder

Devendra Kumar, a young self-made social reformer, was born in a high crime-prone slum where his parents abandoned him at the age of 2 years with his 3-day infant sister. Grown amidst poverty, at the age of 8, he started working as a child laborer. During his balloon-selling, he was snatched & brutally beaten by a group of delinquents & drug addicts. Many mishaps & miseries at a very young age coerced him to find a safe space for him which encouraged him to join a volunteering group with Indian Red Cross & St. John Ambulance, **In 2010 his struggle to save his sister from child marriage and dowry by surviving amidst vulnerability motivated him to work for most vulnerable population for which he established the “Ladli Foundation.”**

He has been honoured with two national award by the Government of India and has been praised by Four successive Presidents of India late Sh. APJ Abdul Kalam, Late. Sh. Pranab Mukharjee, Sh. Ram Nath Kovind & Smt. Draupadi Murmu, respectively.

In 2019, His contribution to the welfare of the lower section of society was commended by the Union Ministry of Social Justice, Government of India and **nominated him for the prestigious Padma Shri Award 2020 (4th Highest Civilian Award of India)**. His grassroots-level initiatives assisted in the liberation of thousands of women and young girls from sexual abuse and exploitation and subsequently empowered them to become self-reliant, for which he was titled as “True Hero” by Mr. Amitabh Bachchan

In 2017, His most significant gender sensitization initiative for gathering twenty thousands of male populations in Run for Laadli Half Marathon at JLN Stadium, Delhi to uphold the idea of Gender Equality was witnessed and deeply praised by the Union Home Minister, Social Justice Minister & Numbers of International Diplomats and Notable Dignitaries & Govt. Officials.

His 23 years continuous actions and innovative initiatives for empowering the oppressed and disadvantaged has also drawn attention on a global scale at the United Nations, where His suggestions have been published twice in high-level political forums of the United Nations in July 2021 and December 2021. Also In the Preliminary session of the 65th Commission on the Status of Women at the United Nations on March 15, 2021, The UN Secretary-General, Mr. António Guterres, praised his work and well acknowledged his influential advocacy for prioritizing women's health and effective efforts to prevent child marriage in developing countries During the 65th Session of the Commission on the Status of Women, he was recognized by UN Secretary-General António Guterres for raising his voice to highlight the agenda of women's health and the elimination of child marriages in developing countries.

Devendra is an emerging global leader, notable speaker and policy analyst, boasts extensive expertise in international relations and development sector. He is also the founder of the South and East Asia Foundation in India and Ladli Foundation USA, a 501(c)(3) nonprofit organization in the United States, serving as an international think tank and has successfully orchestrated prestigious conferences like INDIA & BRICS, INDO-US SUMMIT, INDO-CHINA SUMMIT, CLIMATE CONCLAVE, and NATIONAL DEMOCRACY SUMMIT, uniting global leaders, diplomats, and policymakers to address India's challenges. 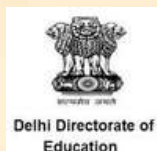

Delhi based NGO initiates humanitarian work for Ukraine war victim women

New Delhi

Amidst the Ukraine – Russia conflict, an Indian non-profit NGO Ladli foundation has come forward to help and rehabilitate WAR-affected Ukrainian young Girls and Women to save them from the risk of trafficking and sexual exploitation.

The NGO has designed its interventions for helping women and children for their smooth rehabilitation in safe shelters and providing them with necessary relief materials, healthcare and counselling on mental health to help them to overcome form trauma that they are facing in everyday life.

In addition to interventions some daily needs items like hygiene kits and sanitary pads will also be made available to them.

"The year 2022 started

with a severe threat of trafficking, sexual exploitation, and other dreadful consequences on Ukrainian Girls and Women due to the ongoing Ukraine- Russia Conflict. It is the time for everyone to display their kind humanitarian acts to save humanity," said Devendra Kumar, Founder of Ladli Foundation

"Ladli foundation has already started working with its volunteers making a concerted effort to identify and register the survivors. As per news sources till February 28, 2022, around 500,000 people have fled Ukraine. Children have been orphaned and women widowed with the displacement going on. This has put women and children at the risk of getting into the vicious trap of human trafficking and exploitation," he asserted.

As per the United Nations, an estimated 80,000 women will give birth in the next three months. Many of them are without access to critical maternal health care.

Ladli foundation has also started a fundraising campaign to help women who are displaced in this humanitarian crisis. Having Special Consultative Status in Economic & Social Council of United Nations Since –2020, Ladli Foundation and its International wing Ladli Foundation USA, with its key expertise, is reaching out to WAR Victim Girls & Women for their complete rehabilitation by providing them social protection & reproductive health services in some of the hardest-to-reach areas with the Support of Govt and local stakeholders.

Ladli Foundation Trust gets special status at UN's ECOSOC

The Ladli Foundation Trust, a social organization known for its unique efforts for the upliftment of women and needy people at the grassroots across the country, has been given the status of Special Consultative Institution in the Economic and Social Council of the United Nations (ECOSOC).

During the UNGA in January, a number of selected names were discussed from across the world, in which the name of Ladli Foundation Trust was proposed unopposed from India for this special status, on which the final decision by the Council has been given recently, wherein the Ladli Foundation Trust officially achieved the recognition.

After receiving this special honor, the organization will be allowed to represent and give written suggestions to the United Nations on the subjects related to the Council. The trust will also have the privilege of making a seven members delegation that can attend

'Shocking! 57 percent young females in Delhi slums diagnosed with multiple health issues'

Healthy citizens are key to a prosperous nation, and when a major section of the population, especially women, suffers from anaemia and under-nutrition, it is impossible for a country to attain progress. In a shocking revelation, about 57 percent young girls and women in Delhi slums are being detected with high lymphocyte count, low haemoglobin and low platelets count.

The eye-opener data has been churned out of a recent campaign titled 'Saheli' being jointly organised by Laadli Foundation Trust and the Delhi Police. Under the campaign, the Laadli Foundation, as part of the ONGC's CSR initiative, is organizing free health check-up camps followed by awareness sessions on sexual abuse, sexually transmitted infections and personal hygiene in various slums of the national capital. So far, the social organization has so far examined 1616 young illiterate girls and women, out of which nearly 57 percent were diagnosed with high lymphocyte count, low haemoglobin level and low platelets count. Medical experts have suggested that this shocking figure indicates that these 57 percent women might 'possibly' be suffering from something more serious, such as a tuberculosis, chronic infections

or some other sexually transmitted diseases, and the government agencies must not ignore it.

Devendra Gupta, founder of Laadli Foundation, who is the man behind the Saheli initiative explains, "In slums, because of the poverty and orthodox mindset, girl children are ill-treated and all their needs, such as food, clothes and education, were neglected by the parents since birth. Further in absence of proper education and awareness, such a girl could not differentiate between good and bad or right and wrong."

"Actually, these are girls who were welcomed to this automatic world with their parents noting it as 'Pata nahi hamne kon se bure karam kiye the ye paida hui' (Don't know what sins we had committed that she had born). No one cares about, needs, care, health or hygiene of these girls throughout their lifespan as the whole family is busy with taking utmost care of the male members," he elaborates.

"These are the daughter who when asks for a glass of milk or some fruits, their own mother denies them for it arguing that she (the daughter) doesn't require such nutritious food as she has to remain at home. While the same luxurious food items (a glass of milk or fruits are still a luxury item for poverty-stricken families) taken away from these daughters are later served to their sibling,

"Meanwhile, these uneducated daughters when attain adolescence don't have much knowledge of menstrual hygiene and similar is the condition with their understanding about various health hazards that might occur due to having unprotected sex," Devendra added. It is worthy to mention that

the Government is focused on 'Save Daughter- Educate Daughter' campaign, but much remains to be done. What about the condition of those unprivileged daughters, who were born much before this campaign of government. This goal will remain unrealized if young girls and women continue to

suffer from deadly diseases and spreading the same of which they are not aware. "In the process of interacting with people of the slum, we recognized the need for a holistic approach. We believe that societal problems arise due to a number of factors occurring simultaneously in society. To effect

changes one has to examine all these various factors, isolate the most important, and develop ways of providing information that motivates people to make rational and safe choices," he noted.

As part of Saheli campaign, the Laadli Foundation had successfully organized camps in highly populated slums at Rang Puri, Vasant Kunj and Munirka Vihar area of South Delhi. The initiative attempts to spread awareness about the evil practices prevailing in the society and to motivate the uneducated/unprivileged slum dwelling young females to raise their voices against the crimes committed by their acquaintances and to protect themselves from any kind of sexual harassment, the effort has been appreci-

ated locals especially the females. The first phase of the initiative was conducted mutually by the Ladli Foundation and the South-West District Police.

"Due to lack of knowledge & awareness about basic hygiene, females got infected with various deadly diseases. Because of illiteracy and poverty, they are forced to tolerate all the suffering alone. Who's going to teach, educate, and motivate them? It is the need of an hour to spread awareness about the taboo prevailing in the society," Devendra asserted.

Tanya Chadha, Chief Coordinator, Ladli Foundation Trust noted that during the counselling sessions it was revealed that the people have to travel to hospitals situated far from their locality when they can no longer bear the suffering caused by the disease. Further in absence of proper treatment and these health complications slowly turns up into a serious one. With little precautions, these complications could have easily been treated at their early stages.

"The Government should take stern action for the safeguard of these sufferers by improving and making necessary changes in the prevailing health services and must appreciate the work done by the NGO's dedicated to saving the girls and for the betterment of the people living in the slums," she said.

This statement is a crux of practical on-field learnings about the plight of women in the marginalized section of society. This is an accumulation of the ground realities witnessed by the founder of the Ladli Foundation Trust, who was born in extreme poverty and abandoned by his parents at the age of two, along with his infant sister. His struggle to save his sister from atrocities and social evils has made him a crusader to save laes of girls and women by protecting them from sexual exploitation, trafficking and providing primary healthcare, education, and social upliftment in slums of India.

When discussing women's empowerment or achieving gender equality, we need to categorize the targeted interventions and areas between developed and developing nations. The challenges for women in developing countries are highly different from developed countries. Thus, policies need to be made differently for developing and developed nations.

In developed nations, the illiteracy rate and poor health condition of women or female feticide is not a major concern, which are the most significant pillars of her development. But when we think about developing countries like India, Nepal, Pakistan, Bangladesh, Africa, and all, the first concern is to save her before birth. Since then, her struggle starts for coming into this world than for equal access to food, education, healthcare, etc. Hence without concern or prioritizing her healthcare, we cannot give her equal job opportunities, positions in Political leadership, etc.

As per India's National family health survey, more than 60 per cent of women are anemic in rural and urban areas while only Approx. 25 per cent of the male population are anemic. Is it because of malnutrition? No! It is because of Gender-Based Violence. We see that women are the principal victims of Anaemia, malnutrition, Sexual and reproductive health issues compared to males. A significantly lesser male population is anemic/malnourished than women, even though 38 per cent of males are alcoholics and more involved in substance abuse. It clearly indicates that the patriarchal mindset and male dominating society have given them more rights and privileges.

When a girl is born, there are a series of other 'problems' that weigh down the Indian parent. UNICEF says that about 1 in 10 girls under the age of 20 have been forced to engage in sex or perform other sexual acts. This pushes parents to keep their girl children at home and compromise on their education.

- Once they start menstruating, other health concerns set in. One in three schools worldwide does not have basic sanitation, putting millions of children's health at risk (WaterAid Report, 2018), girls facing the brunt of it. In addition, almost 23 million girls in India drop out of school annually because of a lack of menstrual hygiene management facilities (Dasra, 'Spot On,' 2014).
- The COVID-19 pandemic has not only increased poverty but also put about 247 million children out of schools (UNICEF 2020). The result of that is losing a safe space in school and seeing an increase in child labor. In fact, over 100 million girls are at risk of child marriage due to COVID-19 (UNICEF 2020).
- Among these crimes, one of the crucial ones that are yet to be eliminated despite being illegal is dowry. In fact, about 7000 dowry deaths were reported in the year 2020 (Statista).
- 355 million women and girls in India lack access to a toilet (WaterAid India Report). Poor sanitation is one of the reasons that may lead to multiple health

issues in women. Many researchers across the world have already provided data to prove this. One of the most apparent pieces of evidence to date suggesting that poor local sanitation may cause anemia is presented in Bleakley (2007), which studied the effects of a hookworm eradication campaign in the U.S. South at the turn of the twentieth century.

- A WaterAid analysis of Institute of Health Metrics figures, released on International Women's Day, identified that illnesses related to a lack of water, basic sanitation, and hygiene were responsible for the deaths of almost 800,000 women around the world in a single year – making it the fifth biggest killer of women behind heart disease, stroke, lower respiratory infections, and chronic obstructive pulmonary disease.
- In India, 95 million toilets have been built all over the country, but a big concern has arisen how people will maintain them? We all know that public toilets in schools, colleges, & public places are alarming and highly dangerous for women's health. Dirty and unhygienic toilets spared infections and cross-contamination that led to keeping women's lives in danger with the risk of pathological leukorrhea, Uterus infection, cervical cancer, etc.

Recommendations

For all Civil Society Organizations:

- Civil societies' role in achieving gender equality is not the work concerning one or two thematic areas or by a few selected organizations. It can only be achieved through public movements even more than all the UNSDGs combined.
- We all need to come together and work in different directions such as Women Healthcare, Education, Female Feticide, Child Marriages, Trafficking, and Forced Prostitution, Eliminating GBV, Race, Caste, and class-based Violence, Legal Rights, Financial & Digital Literacy, Economic Empowerment, Equal Opportunities in all the sectors.

For National Governments:

Especially for countries like India and other developing nations, we need to prioritize women's healthcare and education through a separate mechanism such as the formation of the exclusive Ministries such as:

- Ministry of Women Health
- Ministry of Women Education
- Ministry of Women Entrepreneurship & Social Security.

In India

Because the existing ministries and departments for all these subjects are not sufficient to cater to the issues and challenges related to women.

The UN and its agencies to:

We all know the situation of women and girl children today where they are denied fundamental human rights and their basic needs. They are more vulnerable to social stigmas and evils that vary depending on their cultural and social aspects.

All UN Agencies need to be aligned with Governments, and civil societies' have to decide new parameters for developed and developing nations and work on them firmly.

We need to form separate sub-goals under the SDG-5 to work more effectively and intensively for achieving UNSDGs.

Designing interventions for promoting Sustainable Living among women to involve them in natural and scientifically proven wellness practices such as YOGA and Meditation.

Different types of atrocities, exploitation, inequality and GBV manifest through mental, emotional, economic, and structural violence against women and girls. Thus, Primary Healthcare, Education, Skill Training, Economic Empowerment, Sensitization, Sustainable living practices may play a vital role in addressing the issue at its core.

It creates a holistic and positive environment to disseminate awareness and knowledge amongst children and young adults who have not yet been victims of or perpetrated GBV. Building awareness and a more well-rounded, respectful approach towards one another help in creating more positive individuals.

The two sectors that policymakers across the globe should emphasize while making policies related to women, especially leaders of the developing countries, to reduce GBV. We cannot achieve gender equality on one pillar; we will need many pillars to ensure that these pillars stay strong. We need to end gender-based violence and the root cause; together with global changemakers, this can become a reality.

Any developing Nation can multiply its GDP by reducing GBV.

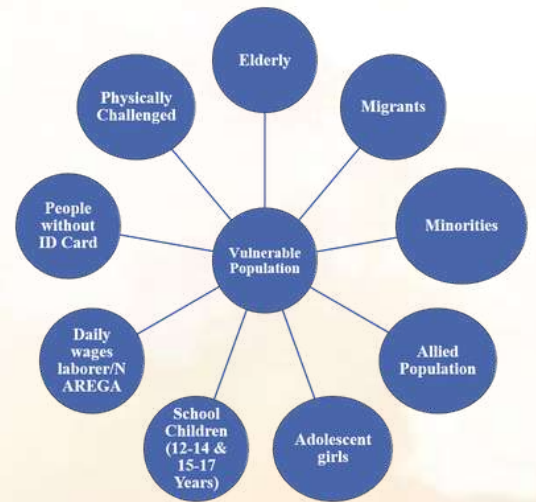

This initiative provides basic education to the children by doing various fun activities and reward-based competitions to develop interest in studies so that they continue their further education in the schools.

Under this initiative we not only focus on children but on their parents too. It is essential to understand that parents need to be motivated to send their children schools as they play an important role to make their future bright and stable. Therefore, we do interactive sessions with the parents to motivate and to make them understand the importance of education.

It is especially designed to reduce access to substance use and crime, render young boys with productive and useful tools, and make them an asset for the society. The program targeted young boys residing in slums and underdeveloped areas of Delhi due to an ever-growing increase in substance use and crime. The focus also extends to dark hours due to the prevalence of crime and substance use in them and the onset of anti-social activities during the time of day, making it even more impactful. The idea of choosing sports, fitness dance, and Yoga to divert them from substance use is its recognition as a means of fun and relaxation, attraction of individuals across all age groups, and its scientific significance making the body release hormones such as dopamine, endorphin leading to reduction of stress and anxiety among individuals and instilment of positivity in all.
